# Cooper's Strategy through 2007 (http://www.notnicemusic.com/2007\_strategy.pdf)

**Abstract:** Don Toman, president of the CUAA from 2005 to 2007 and non-voting observer of Board meetings, summarizes the financial strategy, what went right, and what went wrong. Renegotiation of the Chrysler Building lease and sale of 26 and 51 Astor Place went as planned. The crash of 2008, the delayed construction at 51 Astor Place, the construction over-runs, the lackluster capital campaign, and the institutional operating expense over-runs derailed the strategy. Don believes the tuition issue is a smokescreen for a hidden agenda.

**Abstract:** An explanation of how Cooper hides information in its consolidated statements by reclassification, how the presentation of data makes surplus years look like deficit years and negative cash flows look positive (they particularly enjoy calling things "totals" and then putting additional negative or positive dollars under a double underline), and how Cooper used a change in accounting principle to enable participation in a hedge fund that lost \$80 million in the 2008 crash, with a note about conversion of restricted endowment into unrestricted endowment.

**Abstract:** The financial history of The Cooper Union from 2000 to 2012 in three year intervals, including the launch of the Capital Campaign in 2000, the change in accounting policy that allowed for investment in hedge funds in 2003, the mortgage of the Chrysler Building in 2006 in support of the Master Plan, the media campaign in celebration of the 150<sup>th</sup> Anniversary of Cooper and opening of the NAB in 2009 bragging that Cooper had survived the crash, and how the Board took a historical address about whether Abram Hewitt falsely attributed the "free as air and water" quote to Peter Cooper as a basis in 2012 to justify charging tuition to cover the debt the college became saddled with.

# **Don't Worry, Be HEPI** (http://www.notnicemusic.com/HEPI.pdf)

**Abstract:** How Cooper used the Higher Education Price Index, rather than the Consumer Price Index, to trick the accreditation association into believing Cooper was following its Master Plan, and then, after obtaining reaccreditation, increased expenditures by a whopping 10% per year over 5 years, even after the 2008 crash. The issue of accreditation is also key to whether Cooper could have delayed construction of the NAB.

**Abstract:** How, prior to his first day on the job, President Jamshed Bharucha considered the full-tuition scholarship to be a "cherished aspect" of Cooper, but not as important as growth and globalization. Dr. Bharucha has become a popular speaker in the global education movement, and believes his training in psychology is useful in academic politics.

Cooper Payroll – The Monkey on Their Back (rev 2) (http://www.notnicemusic.com/payroll.pdf)
Abstract: Cooper's Form 990s say that it filed over 700 W-3s in FY 2009 and over 1000 in FY 2009 and 2010.
455 have e-mail addresses – of the \$33.5 million in salaries and benefits, only \$14 million go to teachers, with 18% tenured, 17% untenured full-time, and 64% visiting or adjunct artists and professors. That leaves approximately 200 other employees (at least), described as a big monkey on the back of the faculty. Since student fees can only be used to cover academic instruction, the fees could be raised to \$3.8K per semester, as opposed to the \$38.5K per year Cooper wants to charge in tuition to cover their \$60 million budget.

**Abstract:** An analysis of how 14 of Cooper's 25 trustees are board junkies serving on the boards of several not-for-profits, including 8 at other colleges, how interlocking leads to ongoing escalation of higher education costs, and how the rich people on the Cooper board are unlikely to care about providing a free education to the children of the struggling middle class. Also, the board chairman is cited as saying that most board work occurs in its committees, which elected alumni trustees and CUAA presidents don't get to observe or participate in.

# **Great Hall Financial presentation** (http://www.notnicemusic.com/Drogin\_Financial.pdf)

**Abstract:** Seeking to clarify and fill in the blanks of the financial narrative presented by the Administration to the Cooper community, *The Alumni Pioneer* discusses changes in values of plant assets, the capital campaign, and operating and capital expenses and revenues. The presentation was based upon *The Pioneer*'s interpretation of consolidated financial statements from FY 2000 to 2010, difficult to analyze because of inconsistent accounting and presentation of data, arbitrary reclassifications of funds, and gnomic "notes." Many questions are raised about significant rises in non-academic costs, the development strategy that led to the construction of the New Academic Building, investment in hedge funds, and using imputed income to create paper deficits. Finally, *The Alumni Pioneer* asked for more information from the Cooper finance department, and showed how the Form 990s, consolidated financial statements, and pie charts created by the administration failed to provide the transparency needed by alumni to coherently understand the past and suggest improvements for the future.
